

NURSING HOME ABUSE COMPLAINT PROCESS - ILLINOIS

IDENTIFY THE ABUSE OR NEGLECT

- Physical, emotional, sexual, or financial abuse
- Neglect (poor hygiene, malnutrition, other injuries)
- Violation of residents' rights

ENSURE IMMEDIATE SAFETY (IF URGENT)

- Call 911 if the resident is in immediate danger
- Move the resident to a safe location, if possible

REPORT THE ABUSE

To Illinois Department of Public Health (IDPH)

- Call the IDPH 24-hour Nursing Home Hotline: 1-800-252-4343
- Or file a complaint online at IDPH website

OPTIONAL: REPORT TO OTHER AGENCIES

- Illinois Long-Term Care Ombudsman Program Offers advocacy and assistance
- Adult Protective Services (for non-nursing home facilities)

INVESTIGATION BY AUTHORITIES

- IDPH Investigates the complaint within 24 hours to 7 days, depending on severity
- Investigators may be disciplined or terminated

FINDINGS AND ACTION

- If abuse is confirmed a copy of investigation report
- Legal action (civil lawsuit) may be considered with help from an attorney
